I will sell those properties indicated with an "*"(asterisk), that were previously advertised for one year or more and not sold as required by Chapter 446, Code of Iowa. All Mobile Homes will be offered for sale but only those that have been previously advertised for one year or more and are indicated by an "*"(asterisk) will be sold. After the sale, if the parcel sold is not redeemed within the period provided in Chapter 447, the right to redeem expires and a deed may be issued. All parcels remaining unsold on the sale date will be offered at subsequent tax sales to be held on any business day following the annual sale in which bidders are present and there are parcels still available for sale in the office of the Louisa County Treasurer, commencing June 22, 2022 at 9:00 A.M. Payment must be received **in the office** on or before Friday, June 17, 2022 to avoid property being offered at Tax Sale, Monday, June 20, 2022.

Delinquent taxes can be paid on the Internet web site at: <u>www.iowatreasurers.org</u> until 11:59 P.M., Sunday, June 19, 2022. Delinquent tax payments will not be allowed on the internet web site from 12:00 A.M., Monday, June 20, 2022 through 8:00 a.m., Wednesday, June 22, 2022.

Contact the Louisa County Treasurer's office for further information on Tax Sale procedures and registration information to bid. All steps in the registration process must be completed by 11:59 on June 16, 2022 to bid at the tax sale. Iowa law requires you to be 18 years of age to be a bidder/purchaser.
